

Job Title: Community Rating System (CRS) Coordinator Department: Flood Control District Location: Maricopa County

About the Position:

The CRS Coordinator is a critical role within the Flood Control District, responsible for managing Maricopa County's participation in the National Flood Insurance Program (NFIP) Community Rating System (CRS). By developing, implementing, and maintaining flood risk reduction programs, the CRS Coordinator improves the County's CRS rating, leading to reduced flood insurance premiums for residents in unincorporated areas. This position serves as a leader in public outreach, compliance, and collaboration with state and federal programs.

Key Responsibilities:

1. Program Management (50%)

- Serve as the project manager for updates to the Floodplain Management Plan and CRS Program.
- Oversee program activities to ensure alignment with CRS requirements.

2. Community Coordination (15%)

- Act as the primary contact for the CRS program, serving as a liaison between the Flood Control District and dependent communities.
- Provide guidance and outreach to ensure compliance with state and federal requirements.

3. Policy and Program Development (10%)

 Develop and improve floodplain management policies through collaboration, data collection, and coordination with multiple stakeholders, including municipalities and internal divisions.

4. Public and Stakeholder Engagement (10%)

- Present project updates and issues at public meetings, board meetings, and state or regional advisory groups.
- Communicate effectively with various audiences to support CRS goals.

5. Compliance Support (10%)

- Provide direction to staff regarding compliance with FEMA and other regulatory programs.
- Monitor, report, and audit program activities as required.
- 6. Other Duties (5%)

 Perform additional duties as assigned to support the Flood Control District's objectives.
