

The curriculum below outlines the requirements of the concurrent Master of Urban and Environmental Planning (MUEP)/Master of Public Administration (MPA) program for **online** students. Students are strongly advised to take graduate coursework in the order described. **Most MUEP classes are offered only once per year (Fall only or Spring only).** If students need to deviate from the below plan, contact the MUEP or MPA Program Coordinator to review options.

**MUEP Core and Other Requirements**

The listed classes are required and cannot be waived or substituted, with the exception of PUP 542 and PUP 576.

PUP 542 may be waived for students who took PUP 442 as part of their ASU undergraduate coursework. Submit the [Course Waiver](#) form to check for waiver eligibility. A substitute course for PUP 542 must be chosen from the [Approved Environmental Planning Courses](#) list.

PUP 576 may be waived with ample GIS experience via a petition demonstrating experience and linkages to the MUEP degree. Examples of experience include a formal degree, extended coursework at a graduate level, and/or work experience. Students who have completed GIS 311 with ArcGIS Pro experience as an undergraduate student may also petition the MUEP program for a waiver. Submit the [Course Waiver](#) form to check for waiver eligibility. A substitute course for PUP 576 must be chosen from the [Approved Methods Course](#) list. Substitution of this course is only authorized if the demonstrated GIS experience was from prior to admission into this graduate program.

**MUEP Electives**

Any graduate level GCU, GIS, GPH, or PUP course may be taken as elective. Interdisciplinary courses may be taken, but must be approved by the department if they are not on the [Approved MUEP Electives](#) list. Submit the [Petition for Transfer or Interdisciplinary Elective Courses](#) form to request approval. Electives may be taken at any time; the outline above is a guideline for distributing enrollment equitably

throughout four semesters. **A maximum of 6.0 credits of 400-level coursework may be included on the plan of study but must be approved by the Associate Director of Planning.** Students **must complete at least nine credit hours** of PUP 500- or 600-level coursework and **at least three credit hours** of other courses offered by SGSUP with the prefixes PUP, GPH, GCU or GIS.

Contact the MPA Program Coordinator for approved PAF electives.

### **MUEP Culminating Experience**

The Culminating experience option is a traditional capstone PUP 580 Planning Workshop (5.0 credits). Online MUEP students must complete PUP 580 Planning Workshop as their culminating experience.

### **Time to Completion**

The MUEP/MPA degree is designed to be completed in three years, with a minimum 12.0 credit hours taken per semester (Fall and Spring enrollment only). Fewer hours may be taken but will prolong the time to degree completion.
